Notice to Unitholders on Dividend Payment

Dear Investors,

We thank you for your continued support and participation in the Sub-Fund.

BMO Global Asset Management (Asia) Limited, the Manager of the Sub-Fund (the ‘Manager’) has decided to make dividend payment in respect of Class A USD MDis and Class A HKD MDis for the month ending 31 May 2019. Payment of dividends will be made to Unitholders whose names are entered on the register of Unitholders on the “record date” being 30 May 2019 and the “ex-dividend date” is 31 May 2019. The amount of dividend for each Unit of each Unit Class is summarized in the table below.

Unit Class	Class A USD MDis	Class A HKD MDis
Dividend per unit	USD0.0250	HKD0.0250

The amount distributed will be paid in the class currency of the relevant classes and credited to the account of the relevant Unitholder on or around 10 June 2019. For investors who have elected to have dividends reinvested to purchase additional Units in the Sub-Fund, re-investment will be made on the same date.

Dividend amount is not guaranteed. The Manager may, at its discretion, pay dividends out of capital. Payment of dividends out of capital or effectively out of the capital amounts to a return or withdrawal of part of an investor’s original investment or from any capital gains attributable to that original investment and may result in an immediate reduction of the Net Asset Value per Unit.

The Net Asset Value of the relevant class of the Sub-Fund will be adjusted to reflect such distribution.

Unless otherwise defined in this Notice, capitalized terms used in this Notice shall have the same meaning as defined in the Prospectus of BMO Fund dated July 2018 (the “Prospectus”).
